


Pursuant to Florida Rule of Civil Procedure 1.140(b), Pamela Jo Bondi, Attorney General of Florida, moves to dismiss the Complaint filed by Plaintiffs League of Women Voters of Florida, et al. (the “LOWV Complaint”), or, in the alternative, to strike portions thereof.¹

The Attorney General hereby joins in, and adopts, the “Florida House of Representatives and Florida Senate’s Joint Motion to Dismiss the LOWV Plaintiffs’ Complaint and, alternatively, to Strike Portions of the Complaint” (the “House/Senate Motion to Dismiss”). For the reasons set forth in the House/Senate Motion to Dismiss, the allegations of the LOWV Complaint, even if assumed to be true, do not state a cause of action. Alternatively, should the Court decide not to dismiss the LOWV Complaint, the impertinent and improper allegations identified in the House/Senate Motion to Dismiss should be stricken for the reasons stated in the motion.
