Dear Mr. Busch:

At our March 10 Board of Directors Community Meeting, condominium owners discussed the upcoming redistricting process. I am writing on their behalf in support of a 2011 Redistricting Plan that re-unites our Mays Chapel community with adjoining communities in the second congressional district.

For many years we were represented by the same congressperson as our Lutherville, Timonium, and Cockeysville neighbors. In 2001, our section of Mays Chapel was gerrymandered into District 1, an area that includes all Eastern shore counties, a narrow band of Harford County, and our community. Nearby neighborhoods remained in District 2, resulting in dual election polls at Pinewood Elementary: we vote in the gym (District 1) while most of our neighbors vote across the hall in the cafeteria (District 2).

Senator Zirkin and other Baltimore County representatives support returning our Mays Chapel community to the second congressional district. The current configuration dilutes our voting power, relegating us to a minority status in an Eastern Shore district with whom we share few local concerns.
