STIPULATION OF PLAINTIFFS' FED. R. CIV. P. 30(B)(6) TOPICS





3. The three current at-large City Councilmembers, Messrs. Lanni, Farina, and Santamaria, have had no contact with persons incarcerated at the ACI.
4. Messrs. Wall, Traficante, Lanni, Farina and Santamaria have been contacted by other constituents of Cranston.


