ADVISORY ON SCHEDULES

At the Court’s direction, below-signed counsel for the Rodriguez Plaintiffs has conferred with counsel for all the other non-U.S. plaintiff groups (Perez Plaintiffs, LULAC Plaintiffs, MALC, NAACP Plaintiffs, Task Force Plaintiffs, Quesada Plaintiffs, African-American Congresspersons Plaintiffs, and Plaintiff Congressman Cuellar) (“Private Plaintiffs”) on availability for trial during the coming summer and also on the timing of production of expert reports.

The inquiry asked for “hard” dates of unavailability for trial in this case in the period between Memorial Day (May 29, 2017) and Labor Day (September 4, 2017). It also asked for dates by which any expert reports could be produced. All attorneys responded, and the information below reflects their responses.

I. TRIAL AVAILABILITY

The only dates of Private Plaintiffs' unavailability during the Memorial-to-Labor Day timeframe are:

June 19-June 23

(Mr. Bledsoe) (set for trial in *Hicks v. Austin ISD*; D-1-GN-14-001694, in the 53rd Judicial District of Travis County, Texas)

possibly right before Labor Day (*tentative, still checking*)

(Ms. Perales)(taking child to enter college)

II. PRODUCTION OF EXPERT REPORTS

All Private Plaintiffs anticipate being able to produce any expert reports they intend to use at trial by no later than sometime during the first full week of June, 2017, which ends on June 9th.
