Brief Description of Case Plaintiffs sued in September 2025, seeking a declaration that the Secretary of State violated Section 116.030, RSMo by failing to approve Plaintiffs' referendum petition as to form and that he could not refuse to process signatures gathered before the Governor signed House Bill 1. On the day of trial, Put Missouri First was allowed to intervene over objection and then took a change of judge, delaying resolution of this case. The case was tried in December 2025. The trial court then held the case in abeyance until August 17, 2026, at which point it entered judgment on the merits in favor of Defendant.
