SUPPLEMENTAL DECLARATION OF JOHNNY DUPREE

Pursuant to 28 U.S.C. § 1746, I, Johnny DuPree, declare as follows:

1. I am over the age of eighteen, and I am competent to make this declaration. I provide this declaration based upon my personal knowledge. I would testify to the facts in this declaration under oath if called upon to do so.

2. I submit this declaration to supplement the information contained in my earlier declaration.
3. I am an active member of the Forrest County branch of the National Association for the Advancement of Colored People (NAACP), which is a unit of the Mississippi State Conference of the NAACP. I first became a member of the NAACP over forty years ago, and I have been a life member for over thirty years.
4. I reside in Forrest County, and I am aware that voters can contact the Forrest County Circuit Clerk to identify their district assignments based on the information contained in Mississippi's Statewide Election Management System (SEMS).
5. Prior to Mississippi enacting new senate district lines in 2025, I was assigned to Senate District 34.
6. Under the districts enacted in 2025, I am assigned to Senate District 45, which I currently represent in the Mississippi State Senate after prevailing in the November 2025 special election.
7. I am aware that Secretary of State Michael Watson has directed circuit clerks to re-implement the pre-2025 districts.
8. On August 18, 2026, I visited the Forrest County Circuit Clerk's Office in person to determine whether my voter information in SEMS has been changed to re-assign me to Senate District 34 under the pre-2025 lines. I requested and obtained from the Deputy Clerk a Voter Profile Report generated from SEMS as of August 18, 2026, indicating that I have in fact been re-assigned to Senate District 34. A copy of that report is attached to this declaration as Exhibit A. According to that report, I am in Senate District 34, which the report incorrectly shows as having no incumbent.

9. These changes in SEMS will cause voter confusion, because voters like me who inquire about their district assignment will be told incorrect information about their district and their current incumbent. The districting changes required by the Secretary are unnecessary and will confuse voters about who they can vote for in future elections.

I declare under penalty of perjury that the foregoing is true and correct.
