The House has designated Caliper Corporation to receive our state level redistricting data when it is released. For the time being, I will receive the cd versions of the data.

Hi Kate,

Thank you for your email. It is actually the first received since launching our House Redistricting webpage yesterday. We're hopeful that Tennessee citizens and organization, as well as organizations like yours, utilize me as a contact for questions, comments and concerns as we get ever closer to redistricting this cycle.

As to data, in normal years, both an individual in our Comptroller's Office of Local Government and a GIS position within the legislature have received data (both geographic and state-level redistricting). In addition, the TN House uses the Caliper/Maptitude platform which includes/stores the data information. I have a sense that the Census Bureau has not sent the official data designation letters to the states yet. You might check back with me in mid-February for an update on this.

I enjoyed looking at the Redistricting Data Hub website. I think there's some really good and useful information on it.

Let me know if I can address an follow-up questions.
