



1 Whether the Commission or some other entities or persons (such as the State of  
2 Washington, the Commission members in their official capacities, or, as Defendants Jinkins and  
3 Billig suggest, minority leaders of the Washington Legislature) should be made parties if no one  
4 seeks to intervene is an issue that should be addressed and resolved promptly. This will avoid  
5 any possible concerns from lack of “sharp adversarial presentation of the issues,” *United States*  
6 *v. Windsor*, 570 U.S. 744, 761 (2013), and ensure full consideration and resolution of the case.
